### RESOLUTION NO. 18-09-234

**EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) THRU THE REGIONAL DIRECTOR, REGION IV-B MIMAROPA TO ALLOCATE FUNDS FOR THE CONCRETING OF ROAD SHOULDERS AND RIPRAPPING OF ROADS AT SITIO IMBUYUNGAN, BARANGAY NASUCOB, BULALACAO, ORIENTAL MINDORO**

**"WHEREAS**, the concreting of farm to market road in Sitio Imbuyungan, Barangay Nasucob, this Municipality facilitate the movement of people and reducing transportation time and money, reduce hauling cost of various agricultural produce such as rice and corn, large varieties of fruits, rootcrops and vegetables while its high market value is maintained to the economic gain of the farmers not only in Sitio Imbuyungan but also farmers in the adjacent barangays considering that the Municipality of Bulalacao, Province of Oriental Mindoro is a vast agricultural land in which the primary source of income of the residents is farming;

**"WHEREAS**, road shoulders served as a lateral support to the road pavement by means of protecting the surface from the intrusion of water especially heavy floods caused by typhoons and habagat which ruined several transportation facilities and resulted to social and economic turmoil of the people and the community particularly the poor and helpless families who were heavily affected by this natural calamity;

**"WHEREAS**, there is a need to immediately rehabilitate the transportation facilities through the riprapping of roads and concreting of road shoulders in order not to hamper the shipment of agricultural inputs needed during planting season and shipment of agricultural produce; **Now, therefore, be it**


**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Department of Public Works and Highways (DPWH) thru the Regional Director, Region IV-B MIMAROPA to allocate funds for the concreting of road shoulders and riprapping of roads at Sitio Imbuyungan, Barangay Nasucob, Bulalacao, Oriental Mindoro;






