TO KINDLY ALLOW THE PHILIPPINE COUNCILORS LEAGUE ORIENTAL MINDORO CHAPTER TO USE AND OCCUPY THE BUILDING AND FACILITIES WHICH WILL BE VACATED SOON BY THE PROVINCIAL AGRICULTURE OFFICE IN CAMILMIL, CALAPAN CITY**

**“WHEREAS**, Philippine Councilors League Oriental Mindoro Chapter (PCL OMC) is a strong group of fourteen (14) Sangguniang Bayans and one (1) Sangguniang Panlusod with more than one hundred fifty (>150) active members throughout the province;






