**RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2018-03 OF BARANGAY CABUGAO, BULALACAO, ORIENTAL MINDORO ENTITLED “REALIGNING THE AMOUNT OF TWENTY THOUSAND PESOS (PhP20,000.00) TAKEN FROM IMPROVEMENT OF BARANGAY PLAZA PROPER TO AUGMENT SUPPORT TO SK ELECTION EXPENSE (TRAVEL & SUPPLIES) OF BARANGAY CABUGAO, BULALACAO, ORIENTAL MINDORO” OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**






