BULALACAO, ORIENTAL MINDORO**

**"WHEREAS**, on August 15, 2022, the Sangguniang Bayan of Bulalacao, Oriental Mindoro passed the Resolution No. 22-08-455 where it requested the DENR to conduct assessment of the timberland areas in the Municipality of Bulalacao and to facilitate the issuance of stewardship certificates to the actual occupants until such time that these timberlands be finally converted into alienable and disposable lands for various productive purposes;

**"WHEREAS**, on October 2, 2023, the Office of the Sangguniang Bayan of Bulalacao, Oriental Mindoro received a letter from CENRO-Roxas, Oriental Mindoro stating that there was no new issuance of certificates of stewardship within timberland areas instead they are only in the process of performance evaluation and assessment of expired certificates of stewardship contract;











"WHEREAS, relative to this letter, there is an attached Completed Staff Work Report regarding the assessment of the said timberland areas, furthermore, it stated that under Section 5.2.2(f) of DENR-DILG Joint Memorandum Circular No. 98-01, the management, protection, rehabilitation and maintenance of communal forest have been devolve to the Local Government Units, hence, all lots found inside the said communal forest containing a total area of 59 hectares shall be under the supervision of the Local Government Unit of Bulalacao, Oriental Mindoro in accordance with the existing laws and regulations and subject to the provision that utilization of resources therein shall be in consonance with sustainable development;

"WHEREAS, the Sangguniang Bayan of Bulalacao, Oriental Mindoro is humbly asking the DENR for technical and management support by facilitating the turnover of the said communal forest to the Local Government Unit of Bulalacao, Oriental Mindoro for its complete development benefiting the municipality as whole and prevent the occurrence of ownership of private individuals to the said communal forest; Now, therefore, be it...


