**EARNESTLY REQUESTING HIS EXCELLENCY FERDINAND R. MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND SECRETARY OF THE DEPARTMENT OF AGRICULTURE TO ALLOCATE NECESSARY FUNDS FOR THE CONSTRUCTION OF A SOLAR AND MECHANICAL DRYER IN MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS**, Section 17, of Republic Act No. 7160 otherwise known as the local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities such as industrial research and development services, as well as the transfer of appropriate technology;

**"WHEREAS**, Bulalacao is a 3<sup>rd</sup> class municipality with a vast agricultural land, has 15 barangays and with a total agricultural land area of 10, 325.80 hectares where 6,016 individuals are employed in the agricultural sector;

**"WHEREAS**, solar dryer makes use of solar energy and tap it to dry different kinds of agricultural crops the concept is relatively simple as it involves converting light to heat and subsequently trapping the heat so that it can later be subjected to crops to dry it up;

**"WHEREAS**, mechanical dryer is used to remove water from wet grains by forcing either ambient air or heated air through the grain bulk where it employs high temperatures for rapid drying, the drying process is terminated when the desired final moisture content is reached;

**"WHEREAS**, the Local Government Unit of Bulalacao is humbly asking the Department of Agriculture to allocate funds that would enable the establishment of the solar and mechanical dryers and would support to allow farmers to dry their harvest, reap greater profits and deliver quality food to consumers; Now, therefore, be it...

Marcos, Jr., President of the Republic of the Philippines and Secretary of the Department of Agriculture to allocate necessary funds for the construction of a solar and mechanical dryer in Municipality of Bulalacao, Province of Oriental Mindoro,




