RESOLUTION REQUESTING CONGRESSMAN ALFONSO V. UMALI, JR., 2ND DISTRICT REPRESENTATIVE, PROVINCE OF ORIENTAL MINDORO TO FACILITATE THE RELEASE OF FUND AMOUNTING TO PHP3,000,000.00 INTENDED FOR THE COMPLETION OF COVERED COURT IN BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 17 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities, as such for barangays it includes infrastructure facilities like multi-purpose hall, multi-purpose pavement, plaza, sports center and other similar facilities;

"WHEREAS, Bulalacao, a 3rd class Municipality hounded with financial constraints which is located at the southernmost tip of the Province of Oriental Mindoro, it has a municipal government that provides adequate facilities for the physical development of the community;

"WHEREAS, the covered court in Barangay Balatasan is one of the recently constructed covered courts in the Municipality of Bulalacao, thus there is still a need for its improvement such as the construction of bleachers and basketball board/set that would be useful in any event or program of the barangay and the same shall serve as evacuation center in times of calamities;

"WHEREAS, the completion of the said covered court would not only be beneficial for its residents but it would also support in upholding the structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...


