RESOLUTION NO. 20-01-022

EARNESTLY REQUESTING THE NATIONAL HOUSING AUTHORITY TO GRANT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH SHELTER ASSISTANCE TO RESIDENTS WHOSE HOUSES WERE TOTALLY AND PARTIALLY DAMAGED BY SUPER TYPHOON URSULA

"WHEREAS, the National Housing Authority (NHA) is a government-owned and controlled corporation under the Housing and Urban Development Coordinating Council tasked to develop and implement a comprehensive and integrated housing program which shall embrace among others, housing development and resettlement, sources and schemes of financing and delineation of government and private sector participation;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was hit by Typhoon Tisoy on December 3, 2019 under Storm Signal No. 3 and on December 25, 2019 by super Typhoon Ursula with strong winds and heavy rains ruined the entire municipality where an estimated 90% of houses as reported by the Municipal Social Welfare and Development Office were destroyed as shown by this figure; total damaged is 2,498 and the partially damaged houses reached to 3,596;

"WHEREAS, the agony and a deep sense of loss felt by the residents of Bulalacao particularly those poor and homeless families may be lessen through a shelter assistance from the National Housing Authority providing them a new hope and aspirations to survive and live a normal life ahead; Now, therefore be it....

RESOLVED AS IT IS HEREBY RESOLVED, TO: Earnestly request the National Housing Authority to grant the Municipality of Bulalacao, Province of Oriental Mindoro with shelter assistance to residents whose houses were totally and partially damaged by Super Typhoon Ursula;
