AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO ENTER INTO A COLLECTION AND REMITTANCE AGREEMENT (CRA) WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) REPRESENTED BY ATTY. JERRY F. IBAY, REGIONAL VICE PRESIDENT, PHILHEALTH DESIGNATING THE LGU BULALACAO AS COLLECTING AGENT OF PHILHEALTH IN THIS MUNICIPALITY AND SUCH OTHER TERMS AND CONDITIONS AS MAY BE AGREED UPON BY BOTH PARTIES

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Mayor, Engr. Ernilo C. Villas to represent the Local Government Unit of Bulalacao, Oriental Mindoro to enter into a Collection and Remittance Agreement (CRA) with the Philippine Health Insurance Corporation (PhilHealth) represented by Atty. Jerry F. Ibay, Regional Vice President, PhilHealth designating the LGU Bulalacao as collecting agent of PhilHealth in this Municipality and such other terms and conditions as may be agreed upon by both parties;


RESOLVED FURTHER, That: Any change or alteration in the Collection and Remittance Agreement (CRA) originally presented shall have no effect and therefore null and void;
