RESOLUTION NO. 5

A RESOLUTION REQUESTING THE PROVINCIAL GOVERNOR TO APPORTION TO ALL MUNICIPALITIES, THIS PROVINCE, THE MEDICINES EXTENDED TO THE PROVINCE BY THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE.

WHEREAS, the province of Oriental Mindoro is comprising of fifteen (15) municipalities too large but remote, the inhabitants of which some 80% consist of indigents, poor farmers and laborers;

WHEREAS, these people because of their low situation in lives are solely dependent upon government institutions for their medicines for the simply reason that they cannot afford to buy their medical needs without thereby neglecting their immediate necessities specially now that agricultural products failed to produce the usual yields by reason of the long draught;

WHEREAS, in order to alleviate their sufferings and to little improve their physical health it is necessary that medicines be extended to them gratis et amore.

WHEREAS, this league believed that the only way to help this poor people is to apportion the medicine extended to the province by the Philippine Charity Sweepstakes to each municipality;


WHEREAS, should the assistance be extended to every municipality the same shall be distributed and supervised by the Municipal Health Officer in order to avoid discrimination in the dispensation;

NOW THEREFORE, be it resolved as it is hereby resolved that the Provincial Governor be requested as he is hereby requested that the medicine extended to our province by the Philippine Charity Sweepstakes Office for distribution be apportioned to each municipality.

RESOLVED FINALLY, THAT COPY of this resolution be furnished the Provincial Governor, Calapan, Or. Mindoro, for consideration and appropriate action.
