CHAPTER VIII- MUNICIPAL WATERWORKS OF BULALACAO IN CONJUNCTION THE TRANS-  
FERING OF THE WATERWORKS FROM NATIONAL SEWAGE AUTHORITY TO THE MUNICIPALITY  
OF BULALACAO ORIENTAL MINDORO JANUARY 1972.

D-I- MUNICIPAL WATERWORKS: In pursuance to Section 2317 of the Administra-  
tive Code, and of Section 2, Republic Act No. 2264, the Municipal Council here-  
by to collect, fees charges to any owner or owners of houses who have been ins-  
talled pipes, faucet and used the water supply from the mainline of pipes which  
the collections shall be fixed to wit:


- B-I-a: For each connection in every house which Amount of Tax per Month
- : has two (2) faucets - - - - - ₱ 2.00
- B-I-b: Each connection of more than (2) faucets per
- : flat rate in every house, an additional of
- : two (2)00) per faucet to be collected in excess
- : specified above:
- D-I-c: Permit for new installation of connection granted
- : by the Mayor - - - - - 5.00
- D-I-d: Installation made by pumber from the mainline
- : either by government employee or by private person
- : an installed fee or charge to be collected: - - - 15.00 per install
- D-I-e: Restriction: Before the installation be made a permit
- : be secured from the Municipal Mayor in this shall contain the
- : provisions to the effect that: Upon failure to pay the Monthly
- : rate stated above, a twenty-five percentum (25%) plus additional
- : charge, he/she is liable for presecution and additional all faucets
