AMENDING SECTION 1 OF ORDINANCE NO. 04-06-036, PROVISION ON THE IMPOSITION OF TAXES, FEES AND CHARGES UPON TRANSIENT BUSINESSMEN, "PALANYAG", OPERATING WITHIN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

SECTION 1. Section 1 of Ordinance No. 04-06-036, provision on the imposition of taxes, fees and charges upon transient businessmen, "Palanyag" operating within the Municipality of Bulalacao, province of Oriental Mindoro is hereby amended to read as follows:

"Section 1. Imposition of Fees. There is hereby levied the following fees and charges for all transient businessmen "palanyag" operating within the Municipality of Bulalacao, Oriental Mindoro enumerated and identified as follows:

Application fee	-	Php 25.00
Mayor's Permit	-	200.00
Business tax	-	200.00/linear meter
Medical/Sanitary fees	-	50.00
Service fee	-	50.00
Fire Inspection fee	-	30.00
Garbage fee	-	20.00"

- Kinatawan ng Municipal Assessor's Office



SEC. 2. This Ordinance shall take effect ten (10) days upon approval;


