SPECIAL ORDINANCE NO. 08-05-75

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH GENERAL MANAGER PETRONILO B. BUENDIA REPRESENTING THE PHILIPPINE FISHERIES DEVELOPMENT AUTHORITY (PFDA) GRANTING THE FORMER THE SOLE AUTHORITY TO MANAGE AND OPERATE THE BULALACAO MUNICIPAL FISH PORT SITUATED AT BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO


BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

SECTION 1. In order to alleviate the economic condition of our marginal fisherfolks and provide order in our policies in the shipment and handling of marine produce, the Municipal Mayor is hereby authorized to represent the Municipality of Bulalacao, Oriental Mindoro to enter into a Memorandum of Agreement with General Manager Petronilo B. Buendia representing the Philippine Fisheries Development Authority (PFDA) granting the former the sole authority to manage and operate the Bulalacao Municipal Fish Port situated at Barangay Poblacion, Bulalacao, Oriental Mindoro;


