**SPECIAL ORDINANCE NO. 08-06-76**

**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACT WITH A PRIVATE LAWYER OR A LEGAL CONSULTANT FOR THE PURPOSE OF DEFENDING THE RIGHTS OF THE LOCAL GOVERNMENT UNIT AND ITS OFFICIAL AND EMPLOYEES WHILE IN THE PERFORMANCE OF HIS OFFICIAL FUNCTIONS CHARGEABLE AGAINST THE LEGAL SERVICES FUND UNDER THE OFFICE OF THE MAYOR**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro.

**SECTION 1.** The Municipal Mayor, the Honorable Ernilo C. Villas is hereby authorized to enter into contract with a private lawyer or a legal consultant for the purpose of defending the rights of the Local Government Unit and its officials and employees while in the performance of his official functions chargeable against the legal services fund under the Office of the Mayor;
