SPECIAL ORDINANCE NO. 07-07-06

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A NEGOTIATED CONTRACT WITH ANY LEGITIMATE AND QUALIFIED PERSON, GROUP OR COOPERATIVE FOR THE EXCLUSIVE FISHERY RIGHTS IN VIEW OF THE TWO (2) CONSECUTIVE FAILED BIDDINGS THEREOF

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. Section 149 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that Municipalities shall have the exclusive authority to grant fishery privileges in the municipal waters and impose rentals, fees or charges therefor in accordance with the provisions of this Section and that registered organization or cooperatives of marginal fisherfolks have the preferential right to such fishery privileges and the privilege to gather, take or catch bangus fry, prawn fry or kawag-kawag or the fry of other species and fish by means of nets, traps or other fishing gears may be granted to marginal fisherfolk free of any rental, fee, charge or any other imposition.

SEC. 2. Pursuant to the par. 6, (1), Section 444 of the same law mentioned above, the Municipal Mayor upon authorization of the Sangguniang Bayan represent

the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations and such other documents made pursuant to law or ordinance to which Mayor Emilo C. Villas is hereby authorized to enter into a negotiated contract with any legitimate and qualified person, group or cooperative for the exclusive fishery rights in view of the two (2) consecutive failed biddings thereof;

SECTION 3. This Special Ordinance shall take effect immediately;


