SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE HONORABLE NASSER C. PANGANDAMAN, SECRETARY, DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE GRANT OF THE NECESSARY AMOUNT OF THE LATTER TO THE FORMER TO BE USED FOR THE CONSTRUCTION/REHABILITATION OF SITIO MARADANUM, BARANGAY CAMPAASAN-SITIO SINEGARA-SITIO CAW-AYAN, BARANGAY POBLACION FARM TO MARKET ROAD, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
