SPECIAL ORDINANCE NO. 07-06-03

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACTUAL AGREEMENT WITH MR. BENJAMIN H. SALAS FOR THE DEVELOPMENT OF THE WATER SYSTEM AT SITIO TULALE, BARANGAY POBLACION INCLUDING THE PROPOSED INFRASTRUCTURAL FACILITIES THAT MAY BE CONSTRUCTED THEREIN THAT SHALL ENSURE THE SUFFICIENT SUPPLY OF POTABLE WATER AT BARANGAYS POBLACION AND CAMPAASAN

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, Hon. Ernito C. Villas is hereby authorized to enter into contractual agreement with Mr. Benjamin H. Salas for the development of the water system at Sitio Tulale, Barangay Poblacion including the proposed infrastructural facilities that may be constructed therein that shall ensure the sufficient supply of potable water at Barangays Poblacion and Campaasan;


SEC. 2. This Special Ordinance shall take effect immediately.
