SPECIAL ORDINANCE NO. 05-07-008

OVERRIDING THE VETO ISSUED BY THE MUNICIPAL MAYOR DATED, JULY 13, 2005 RELATIVE TO ORDINANCE NO. 05-06-049 ENTITLED "ADOPTING AND FIXING A NEW SALARY/WAGE RATE OF CERTAIN MUNICIPAL EMPLOYEES ON JOB ORDER BASIS AND CLASSIFYING THEIR STATUS THEREOF"

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. By virtue of the power vested in this Sanggunian under Section 55, par. c of Republic Act Act Numbered 7160 otherwise known as the Local Government Code of 1991 the veto message dated, July 13, 2005 by the Municipal Mayor with regards to Ordinance No. 05-06-049 is hereby overridden for the following reasons; to wit:


i. The veto power was exercised not on the ground of "ultra vires" maintaining the Sanggunian has the power under Section 447, par. VIII which says "Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the municipal government"; and therefore there

is no liability for this Body to commit an action beyond the province of its legal authority, hence the veto is 'ipso facto' not applicable on the alleged defects of the subject ordinance and therefor it is deemed approved as if signed by the Local Chief Executive;


SECTION 2. This Special Ordinance shall take effect immediately;
