### SPECIAL ORDINANCE NO. 05-02-001

**TEMPORARILY CLOSING CERTAIN STREETS AT POBLACION, BULALACAO, ORIENTAL MINDORO"**

**Sponsor: Councilor Rosalinda M. Cabagay**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** In order to accommodate the selling of goods, merchandise, foodstuffs, commodities or articles of commerce by transient businessmen or traders to the general public during the Barangay Fiesta of Poblacion, Bulalacao, Oriental Mindoro, the following streets are hereby temporarily closed from February 11 to February 28, 2005, to wit:

- i. Templanza Street- from F. Atienza Street to A. Salas Street
- ii. Pantilo Street- from A. Contreras Street to Bendolo Street
- iii. Bendolo Street- from Pantilo Street to Bago Street
- iv. Bago Street- from J. Templanza Street to C. Bendolo Street

**SECTION 2.** Any person violating this ordinance shall suffer the penalty of 6 months imprisonment or shall be fined by an amount of Php2,500.00 or both such fine and imprisonment at the discretion of the court

**SECTION 3.** This ordinance shall take effect immediately.






