ORDINANCE NO. 05-10-054

FIXING THE RENTAL FEES OF THE POST-HARVEST FACILITIES OWNED AND MAINTAINED BY THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

SECTION 1. The rental fee of the Post-Harvest Facilities owned and maintained by the Municipality of Bulalacao, Oriental Mindoro to any interested persons are hereby authorized and fixed as follows:

- a. Combined Tresher Husker Sheller – **One and one half gantas per cavans = 1 ½ gantas/cavan or its equivalent prevailing market price.**
- b. 6-Tonner Flatbed Dryer – **Fifty centavos per kilo 50 cents/kilo**

It is understood that the fuels and maintenance of the abovementioned machineries shall be the sole responsibility of the Local Government Unit.


SECTION 2. The Municipal Treasurer or his duly authorized representatives shall issue an official receipt as evidence of payment of rentals imposed herein. The same shall be presented by the applicant to the Municipal Agricultural Officer for screening and evaluation, scheduling and other matters relative to the rentals of the said equipments.


SECTION 3. All activities and requests relative to the rentals of the Post Harvest Facilities shall be directed and coordinated with the Municipal Agricultural Office which shall likewise exercise full control over the management of the said equipments.




SECTION 5. EFFECTIVITY. This ordinance shall take upon approval.


