SPECIAL ORDINANCE NO. 06-07-15

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACT WITH EDUARDO C. ACERON FOR THE ACQUISITION OF A PARCEL OF LAND CONTAINING AN AREA OF 120 SQ.M. SITUATED AT BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO TO BE USED AS ACCESS ROAD FROM THE PROVINCIAL ROAD GOING TO THE MUNICIPAL PUBLIC MARKET

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to ensure the smooth flow of traffic at Barangay Campaasan particularly to facilitate the motorists and pedestrians alike in going to the Municipal Public Market, the Municipal Government initiated the construction of an access road at that area that the Municipal Mayor, Ermito C. Villas is hereby authorized to enter into contract with Eduardo C. Aceron in consideration with a parcel of land containing an area of 120 sq.m. in the amount of Sixty Thousand Pesos (Php60,000.00) to be used as an access road.


SECTION 2. This special ordinance shall take effect immediately.




