SPECIAL ORDINANCE NO. 06-04-09

SPECIAL ORDINANCE CREATING AND PROMOTING CERTAIN POSITIONS IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AND ALLOCATING THE NECESSARY FUNDS THEREFOR IN THE MUNICIPAL ANNUAL BUDGET

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In the observance of the provision of RA 7160 otherwise known as the Local Government Code of 1991 notably Section 76 which provides that every Local Government Unit shall design and implement its own organization structure and staffing pattern taking into consideration its service requirements and financial capabilities, subject to the minimum standards and guidelines prescribed by Civil Service Commission, this Sanggunian hereby creates and promotes the hereunder positions; to wit:

SECTION 3. The position of Population Program Worker I (SG-5) may likewise be appointed according to the availability of funds.


SECTION 4. This special ordinance shall take effect immediately.


