**SPECIAL ORDINANCE NO. 06-04-06**

**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES (LBP), ROXAS BRANCH, ROXAS, ORIENTAL MINDORO FOR THE GRANT AND RENEWAL OF SALARY LOANS OF QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF BULALACAO AND RATIFYING THE SAME CONTRACT**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


**SECTION 1.** In order to help certain municipal officials and employees meet their financial needs and obligations, the Municipal Mayor, Engr. Ernile C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Land Bank of the Philippines (LBP), Roxas Branch, Roxas, Oriental Mindoro for the grant and renewal of salary loans of these employees and to ratify the same contract;

**SECTION 2.** This special ordinance shall take effect immediately.


