SPECIAL ORDINANCE NO. 06-04-05

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DIRECTOR RODOLFO M. GUIEB, REGIONAL DIRECTOR, DEPARTMENT OF AGRICULTURE, REGION IV-B (MIMAROPA) FOR GRANTING THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH A 6-TONNER FLATBED DRYER WITH 12.5 HP DIESEL ENGINE AMOUNTING TO SEVEN HUNDRED FIFTY THOUSAND PESOS (PHP750,000.00) INTENDED FOR THE YELLOW CORN PRODUCTION AT THE SOUTHERN PART OF THIS MUNICIPALITY MOST PROBABLY AT BARANGAY MAUJAO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. The basic policy on local autonomy under Section 25 of Republic Act 7160, that national agencies and offices with project implementation function shall coordinate with one another and with the local government units concerned in the discharge of these functions, and shall ensure the participation of local government units both in planning and implementation of said national projects in accordance with Section 444 par. A (b.vi) this Sanggunian hereby authorize the Municipal Mayor, Engr. Ernito C. Villas to enter into a Memorandum of Agreement with Director Rodolfo M. Guieb, Regional Director, Department of Agriculture, Region IV-B (MIMAROPA) for granting the Municipality of Bulalacao, Province of Oriental Mindoro with 6-tonner Flatbed Dryer with 12.5 HP Diesel Engine intended for the yellow corn production at the southern part of the town most probably at Barangay Maujao;




SECTION 2. This special ordinance shall take effect immediately,






