**SPECIAL ORDINANCE NO. 08 - 06- 082**

**AN ORDINANCE ALLOWING THE ESTABLISHMENT OF FISH CAGES AT THE TAMBARON ISLAND SITUATED AT BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1. Area.** The establishment of fish cages at the Tambaron Island situated at Barangay Maasin, Bulalacao, Oriental Mindoro formed by the following coordinates is hereby allowed:

- From latitude 12° 16' 54.4" N longitude 121° 22' 4.8" E
- to latitude 12° 16' 54.9" N longitude 121° 22' 12" E
- to latitude 12° 16' 42.4" N longitude 121° 22' 20.4" E
- to latitude 12° 16' 44.4" N longitude 121° 22' 29.5" E
- to latitude 12° 16' 48.2" N longitude 121° 22' 36.8" E
- to latitude 12° 16' 50" N longitude 121° 22' 38.3" E
- to latitude 12° 16' 49.9" N longitude 121° 22' 30.2" E
- to latitude 12° 16' 50.5" N longitude 121° 22' 17.2" E
- to latitude 12° 16' 51.2" N longitude 121° 22' 7.6" E

**SEC. 2. Administration and Control.** The establishment of fish cages at the Tambaron Island is hereby placed under the administration and control of the Local Government Unit of Bulalacao in consultation with the Provincial Government of Oriental Mindoro and Environmental Management Bureau. The Local Government of Bulalacao shall prepare the implementing rules and regulations as shall be necessary to regulate the number of cage and safeguard the environment.

SEC. 3. The establishment of fish cages at the abovementioned place is only allowed for the maximum of three (3) years.

SEC. 4. Prohibition. It shall be unlawful to conduct fishing activities in the vicinity of the abovementioned place that may cause damage to marine fish under culture.

SEC. 5. Penalty. Violation of this ordinance shall subject the offender to the penalty of fine of Five Hundred Pesos (Php500.00) to Two Thousand Five Hundred (Php2,500.00) or by an imprisonment of not less than fifteen (15) days but not more than six (6) months or both such fine and imprisonment at the discretion of the Court.

SEC. 6. Separability Clause. If for any reason, any parts or sections of this ordinance are found to be inconsistent with any applicable laws or rules, other parts hereof shall continue to be in full force and effect.

SEC. 7. This Ordinance shall take effect ten (10) days after its posting.
