ORDINANCE NO. 15-02-144

AN ORDINANCE ESTABLISHING THE MAASIN FISH SANCTUARY

SPONSOR: Councilor Gideon B. Abuel

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro

SECTION I. Title and Purpose. There is hereby established the Maasin Fish Sanctuary for the protection and conservation of the fisheries and aquatic resources in Barangay Maasin pursuant to Section 2 paragraph A and G of Republic Act 8550.

SEC. 2. Site and Coverage. The Maasin Fish Sanctuary is that body of waters consisting of some eighteen (18) hectares, situated in the northwest of Maasin Island enclosed by imaginary straight lines drawn and connecting the following points:

SEC. 3. Prohibition. It shall be unlawful for any person, whether natural or juridical to conduct a cause to be conducted any fishing operation or take, catch, or gather, destroy or kill, any fish or fishery aquatic species within the fish sanctuary, or in any manner disturb or drive away therefrom any fish fry or fish eggs.

SEC. 4. Enforcement. This Ordinance shall be implemented by duly authorized personnel of the Municipal Agriculture Office, deputized fish warden, FARMCs, Barangay Officials in coordination with Philippine National Police and other law enforcement agencies.


SEC. 5. Penalty. Violation of this ordinance shall subject the offended to the penalty of fine from five hundred pesos (P500.00) to two thousand five hundred pesos (P2,500.00) or by imprisonment of not less than fifteen days (15) but not more than six (6) months or both such fine and imprisonment in the discretion of the court.


SEC. 6. All ordinances inconsistent hereof are hereby repealed, modified accordingly.
