**SPECIAL ORDINANCE NO. 16-12-55**

**SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BENEFICIARIES OF CORE SHELTER ASSISTANCE IN BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO UNDER THE EMERGENCY SHELTER ASSISTANCE PROGRAM THROUGH THE BOTTOM-UP BUDGETING FUNDED BY THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT AND RATIFYING THE SAME**






