SPECIAL ORDINANCE NO. 16-10-50

SPECIAL ORDINANCE GRANTING FINANCIAL INCENTIVE TO OFFICIAL REPRESENTATIVE OF BULALACAO, ORIENTAL MINDORO TO THE ANNUAL SEARCH FOR MISS ORIENTAL MINDORO, THEREBY MODIFYING SPECIAL ORDINANCE NO. 14-11-41-A

SPONSOR: SB MEMBER DEXTER R. GONZALES
CHAIRMAN: Committee on Tourism, Trade, Commerce and Industry

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro to modify Special Ordinance No. 14-11-41-A entitled "Special Ordinance Granting Annual Financial Incentive to the Chosen Official Miss Bulalacao to Represent the Municipality of Bulalacao, Oriental Mindoro in the Search for Miss Oriental Mindoro in the Amount of Fifteen Thousand Pesos (PhP15,000.00)" which shall now be read as follows:

SECTION 1. TITLE. The Special Ordinance shall be entitled "Special Ordinance Granting Financial Incentive to Official Representative of Bulalacao, Oriental Mindoro to the Annual Search for Miss Oriental Mindoro";

SEC. 2. FINANCIAL INCENTIVE. The Local Government Unit of Bulalacao, Oriental Mindoro shall grant financial incentive to the qualified candidate in the amount of Fifteen Thousand Pesos (PhP15,000.00) within five (5) working days after the pageant proper;

SEC. 3. REQUIREMENTS. The incentive shall be granted after the following requirements have been submitted or satisfied:










- a. Certification from the Miss Oriental Mindoro Charities incorporated or Miss Bulalacao Search Committee that the claimant actually represented the Municipality of Bulalacao, Oriental Mindoro to the Search for Miss Oriental Mindoro within the same year of her reign as Miss Bulalacao;
- b. At least five (5) 5R colored photos showing the candidate of her participation to pageant activities;
- c. One (1) 10R colored portrait photo;
- d. Recent Bio-data of the candidate

These requirements shall be submitted to Tourism Officer of the Local Government Unit of Bulalacao who shall issue certificate of entitlement. The Municipal Accounting Office and Municipal Treasury Office shall ensure that the certificate of entitlement requirement is complied with prior to the disbursement of financial incentive.

SEC. 4. FUND. There shall be annual allocation for this purpose under the maintenance and other operating expenses of the Office of the Municipal Mayor of the Local Government Unit of Bulalacao, Oriental Mindoro.

SEC. 5. EFFECTIVITY. This Special Ordinance shall take effect immediately upon its approval. A copy of the approved Special Ordinance shall be given to offices, organizations and individuals mentioned herein and shall be posted on bulletin board of the Local Government Unit of Bulalacao.


