RESOLVED AS IT IS HEREBY RESOLVED, To: Enact an Ordinance creating Bantay Dagat Task Force (BDTF) at the Municipality of Bulalacao, Province of Oriental Mindoro;

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro;

SECTION 1. TITLE. This Ordinance shall be known as "AN ORDINANCE CREATING BANTAY DAGAT TASK FORCE (BDTF) AT THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO"

SECTION 2. DECLARATION OF POLICY. The Municipal Government shall have jurisdiction over municipal waters. It shall be responsible for the management, conservation, development, protection, utilization, and disposition of all fishing and fishery/aquatic resources within the municipal water of Bulalacao. It shall also provide preferential rights in the management and access to the fishery for marginal fishermen who are residents of this municipality.

SECTION 3. Creation and Composition. The Bantay Dagat Task Force hereinafter referred to as "BDTF" is hereby created for the purpose of effectively discharging the powers and functions prescribed under R.A. 7160, R.A 8550 as amended by R.A 10654 and Municipal Ordinance No. 98-09-017 of Bulalacao, Oriental Mindoro; and provided in this ordinance the BDTF shall be a collegial body. It shall be composed of a chairman and representatives from the following government, organizations and duly accredited/registered NGO's and PO's to wit

SECTION 4. General Power Duties and Function. The authority and responsibility for the exercise of the LGU's powers and functions over the maintenance, preservation, conservation and promotion of marine resources within the municipal water of Bulalacao, Oriental Mindoro shall be vested in the BDTF which shall include but shall not be limited in taking the necessary measures against pollution, illegal fishing, cutting of mangrove trees, collecting, gathering or quarrying of corals and endangered marine species, pebbles, aquatic plants and animals to be used as aquatic collections;

SECTION 5. SPECIFIC POWERS AND FUNCTIONS OF BANTAY DAGAT. In addition to the powers, duties and functions vested under section 4 of this ordinance "BDTF" shall have the following powers and functions:

- a) Enforce all fisheries laws, ordinances and applicable rules and regulations within the jurisdiction of municipal waters;
- b) Advise the Local Chief Executive and shall serve as an advisory committee to the Sangguniang Bayan on all matters involving fisheries;
- c) Apprehend any violators of fisheries laws and ordinance caught within the jurisdiction of this municipality;
- d) Deliver the offender to the nearest competent authority and file the necessary case before the court of jurisdiction within the legal prescriptive period of time and shall act as witness in favor of the state;
- e) Establish an efficient and effective seaborne patrolling schedule which shall not be lesser than four(4) times a week or as necessary as the case may be;
- f) Conduct survey and compiled statistical data for the proper evaluation of the efficiency and effectiveness of anti-illegal fishing campaign;
- g) Render to the Chief/Executive and to the Sangguniang Bayan a quarterly report on its activities and accomplishment after the end of every quarter which shall include an appraisal of the conditions obtaining in the team and recommendations for appropriate remedial legislation;
- h) Perform such other functions necessary to carry out the provision of this ordinance and as the Local Chief Executive may direct.

SECTION 6. APPROPRIATION. The Local Government Unit should appropriate the necessary amount to carry out the provision of this in its annual or supplemental budgets;

SECTION 7. REPEALING CLAUSE. Other ordinance, resolution or Executive Order inconsistent with the provision of this ordinance are hereby repealed or modified accordingly;

SECTION 8. EFFECTIVITY. This Ordinance shall take effect after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao;


