MUNICIPAL ORDINANCE NO. 18-07-208

AN ORDINANCE GRANTING MONTHLY COMMUNICATION ALLOWANCE TO MS. RHEA B. DE GUZMAN, PROGRAM CHAIRPERSON, BS TOURISM MANAGEMENT, MINSCAT BULALACAO EXTENSION CLASS IN THE AMOUNT OF ONE THOUSAND PESOS (PhP1,000.00) CHARGEABLE AGAINST THE OFFICE OF THE MUNICIPAL MAYOR

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro (LGU of Bulalacao) to maintain empowered, high morale, and productive workforce. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991 to determine salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds.

SEC. 2. ENTITLEMENT. Ms. Rhea B. de Guzman, Program Chairperson, BS Tourism Management, MinsCAT Bulalacao Extension Class shall receive a monthly communication allowance in the amount of One Thousand Pesos (PhP1,000.00). However, if she incurs unauthorized absences or if she shall be on leave of absence for at least ten

(10) calendar days, she shall not receive this benefit proportionate to the number of days absent. The concerned employee shall start receiving this allowance effective June 1, 2018;

SEC. 3. NON-INCLUSION IN INCREASE. Incumbent position stated herein shall not be covered by PhP1,000.00 across the board monthly increase of this allowance effective January 01, 2017 as mentioned in Section 3 of Special Ordinance No. 16-09-41

SEC. 4. FUND. There shall be annual allocation for this allowance in the Office of the Municipal Mayor under communication expense budget and accounting code under the Maintenance and Other Operating Expenses.










SEC. 5. FUND DISBURSEMENT. Disbursement shall only be allowed upon presentation of statement of account or official receipt of payment for communication expense issued by legitimate retailer or dealer of communication services or products.

SEC. 6. REPEALING CLAUSE. Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

SEC. 7. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.

SEC. 8. EFFECTIVITY. This Ordinance shall take effect June 1, 2018.




