REALIGNING THE AMOUNT OF ONE MILLION THIRTY THOUSAND EIGHT HUNDRED FORTY NINE PESOS AND EIGHTY TWO CENTAVOS (PhP1,030,849.82) TAKEN FROM UNEXPENDED BALANCE OF 5% CALAMITY FUND, CY-2020 TO CERTAIN PROGRAMS, PROJECTS AND ACTIVITIES LIKEWISE UNDER THE 5% CALAMITY FUND NECESSARY FOR IMMEDIATE RESPONSE AID AND MEASURES TO CURTAIL AND ELIMINATE THE THREAT OF COVID-19 PANDEMIC
