





**MDRRMC RESOLUTION NO. 03, Series of 2025**

A RESOLUTION APPROVING THE REPROGRAMMING AND REALIGNMENT OF FUNDS FROM DIFFERENT PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs) OF THE MDRRMF TRUST FUND AMOUNTING TO ONE MILLION THREE HUNDRED SIXTY TWO THOUSAND PESOS (₱1,362,000.00) AND FROM THE CURRENT APPROPRIATION AMOUNTING TO ONE MILLION FIVE HUNDRED THOUSAND PESOS (₱1,500,000.00) FROM THE PROJECT "CONSTRUCTION/REHABILITATION AND IMPROVEMENT OF EVACUATION CENTER" TO THE PURCHASE OF HYDRAULIC SPREADER CUTTER

**WHEREAS**, Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," mandates all Local Disaster Risk Reduction and Management Councils (LDRRMCs) to ensure the effective and efficient implementation of DRRM programs, projects, and activities;

**WHEREAS**, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of Bulalacao recognizes the necessity to maintain operational readiness, support disaster response and operational activities and the need to strengthen its rescue and emergency response capabilities through the acquisition of a Hydraulic Spreader Cutter, a vital lifesaving equipment essential in vehicular extrication, building collapse rescue operations, and other emergency situations;

**WHEREAS**, the MDRRMO, after review and evaluation, identified several PPAs under the MDRRM Trust Fund that may be reprogrammed and realigned to support this priority need without affecting other ongoing or essential activities;

**WHEREAS**, the total amount to be reprogrammed and realigned from various PPAs of the MDRRM Trust Fund is ₱1,362,000.00, broken down as follows:
