RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 4 ✓

AMENDING RESOLUTION NO. 1, ORDINANCE NO. I, S. OF 1981 BY FIXING THE RATE OF WATER SERVICE FEES IN THIS MUNICIPALITY FROM ₱5.00 TO ₱10.00 MONTHLY PER FAUCET CONNECTED OR INSTALLED AND AN ADDITIONAL FEE OF ₱5.00 PER ADDITIONAL INSTALLATION OF FAUCET THEREAT

SECTION 1. All residents of this town who desire to connect or install water pipes from the mainline to their house are hereby obliged to pay water service fees, the amount of from ₱5.00 to ₱10.00, monthly, per faucet connected or installed and an additional fee of ₱5.00 per additional faucet installed or connected thereat;

SECTION 2. No person is allowed to connect water pipes from the mainline or from any pipes already connected from the mainline unless the corresponding fees of ₱25.00 as installation fee be paid to the Municipal Treasurer or his duly authorized representatives;


SECTION 3. Violation of this Ordinance or parts hereof shall be fined the amount of ₱50.00 to ₱500.00 AND An imprisonment of 15 to 30 days or both such fine or imprisonment at the discretion of the court;


SECTION 4. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;


SECTION 5. This Ordinance shall take effect immediately.


