RESOLVED, to approve the following Resolution:

RESOLUTION NO. 17

RECOMMENDING MR. NACHOR S. CABAGAY TO THE REGIONAL DIRECTOR, DEPARTMENT OF FINANCE, MANILA FOR APPOINTMENT AS MUNICIPAL TREASURER OF BULALACAO, ORIENTAL MINDORO

WHEREAS, Mr. Boromao S. Lagunday will be retiring on August 1985, as Municipal Treasurer of Bulalacao, Oriental Mindoro;

AND WHEREAS, when Mr. Boromao S. Lagunday retires, the office of Municipal Treasurer will be left vacant;

WHEREAS, this town has a son who is qualified to fill the vacant position to be left by Mr. Boromao S. Lagunday and he is no other than Mr. Nachor S. Cabagay;

WHEREAS, as Municipal employee of this town, Mr. Nachor S. Cabagay possessed the qualifications enumerated as follows: a) First grade Professional and Local Treasury officer eligibility; b) Municipal Bookkeeper from July 1, 1972 to September 30, 1975; c) Acting Municipal Treasurer from October 1, 1975 to December 31, 1976; and d) Assistant Municipal Treasurer from January 1, 1977 to date;

WHEREAS, it has been observed by this Honorable body, that mostly of Municipal Treasurers, assigned in this town and residing from other municipalities, because of far distance could not attend office hours regularly, hence official business transactions affecting their office cannot be acted in due time;

WHEREAS, the people of this town needs a prominent person and a resident of this municipality to be appointed as Municipal Treasurer;

WHEREAS, in view of the above, the Sangguniang Bayan feels the need of extending support by recommending Mr. Nachor S. Cabagay for appointment as Municipal Treasurer of this municipality;

NOW, THEREFORE, resolved as it is hereby resolved to recommend for appointment, Mr. Nabhor S. Cabagay to the Ministry of Finance, Manila as Municipal Treasurer of this Municipality when Mr. Boromeo S. Legunday retires on August 1985;

RESOLVED, FURTHER, that copies of this resolution be furnished, the Regional Director, Local Government Finance, Finance building, Manila, the Regional Director, Region 4, Batangas City for consideration, the Provincial Treasurer and the Provincial Auditor, Calapan, Oriental Mindoro for their information, guidance and reference;
