RESOLUTION NO. 6

On motion by Hon. Wilfredo F. Embile, seconded by Hon. Jose Paigao,  
RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 2

REQUIRING CINEMATOGRAH AND VITA MAX OPERATORS/ OWNERS TO CONSTRUCT TOILET FACILITIES, INSTALL FIRE EXITS, WINDOWS AND VENTILATORS IN THE BUILDING WHERE SHOWBUSINESS IS PERFORMED

WHEREAS, moviegoers are insecure when a building used in the showbusiness has no toilet facilities, fire exits, windows and ventilators;

WHEREAS, In order to regulate the construction and the installation of the above, the Sangguniang Bayan hereby ordains, that:

SECTION 1. All Cinematograph and Vita Max operators/ owners who are engage in show business in this municipality are hereby required to construct toilet facilities, install fire exits, windows and ventilators in the building wherein pictures are shown for the use of moviegoers;

SECTION 2. No Cinematograph and Vita Max operators shall be allowed to operate showbusiness unless they fully abide with the provisions of Section I hereof;

SECTION 3. Failure of the management to comply the above requirements, the establishment shall be ordered close;

SECTION 4. Violation of this Ordinance or parts thereof shall be fined the amount of ₱500.00 to ₱1,000.00 and imprisonment of 15 to 30 days or both such fine and imprisonment at the discretion of the court;

SECTION 5. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 6. This Ordinance shall be effective ten days after its passage;
