WHEREAS, almost of the 75% of the total population in this municipality are farmers who depend on rice and corn as the mainstay of their livelihood;

WHEREAS, the non-participation of the National Food Authority in the procurement, creat a great decrease of farm price of palay and corn which now dictated by big businessmen;


RESOLVED, FURTHER, that copies of this resolution be furnished, Minister Ramon Mitra Jr. Quezon City for consideration and proper action.


