The session was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Secretary with the members answering present when their respective names were called.

The minutes of the previous session was also read by the Secretary and there no objection so on motion of Hon. Ludovico Silang, duly seconded by Hon. Hon. Emelio Gregorio, the minutes stands as confirmed.

RESOLUTION NO. 48

ADOPTING THE SANGGUNIANG BAYAN RULES OF PROCEEDURE OF BULALACAO, ORIENTAL MINDORO

WHEREAS, the Sangguniang Bayan rules of Proceedure is hereby adopted as guidelines for Sangguniang Bayan members during session;

WHEREAS, these rules of Proceedure are enumerated as follows, to wit:

SANGGUNIANG BAYAN RULES OF PROCEEDURE

1. PRESIDING OFFICER- The Mayor acts as the Presiding officer in all sessions. In case the Mayor is absent, the Vice Mayor acts as the Presiding officer Pro Tempore. He shall not vote even in case of tie. If both the Mayor and the Vice Mayor are absent and the Sangguniang Bayan constitute a quorum they shall elect one of the members to act as the temporary presiding officer. Temporary presiding officer shall not vote incase of tie.

2. QUORUM- Majority of the members present consitute a quorum. If there is no quorum the members present shall call the attention of these members present from time to time to attend the session. They may seek the assistance of the Police to arrest the members absent and compel them to attend the session or impose a fine upon him in such amount or shall have been previously prescribed by an Ordinance. (Section 148, Batas Pambansa Blg. 337 otherwise known as the local government code.)

3. PRESENTATION OF BUSINESS - All members of Sangguniang bayan has the privilege to present business during session for deliberation and discussions. However no new business shall be presented unless the first one is through or finish.

4. HOW TO INTERPELATE - If a member is on the act of deliberating business, no member shall be allowed to interpellate if the speaker has not yet finish deliberating. Members of the Sangguniang bayan are not allowed however to interpellate AT THE SAME TIME. They must see to it that the speaker has already finish deliberating, then one may raise his hand and with the permission of the Presiding officer he may stand and speak.

5. ORDER - Any member who just stand and speak when another member has still the floor may-be stopped by the presiding officer by saying "You are out of order."

6. DIVISION OF THE HOUSE - Disagreement of members on the business presented and deliberated may result to the division of the house. The Presiding officer can settle this by means of "VOTATION" to fine out the PRO & CON. In case of tie the chairman may cast his vote just to break the tie.

7. SUSPENSION OF THE SESSION - Any member may move and duly seconded by another to suspend the session in order to entertain visitors or persons invited to attend the sessions.

8. DISORDER DURING SESSION - In case a discussion or heated argument may arise among the members the Presiding officer may call for the recess of the session by using his gavel of banging his gavel.

9. DEAD MOTION - One or two members may move and second the motion. A motion without being seconded is called a "DEAD MOTION". A member and duly seconded by another may move for disapproval of the resolution or Ordinance. Or the Presiding officer may declare the motion as "DEAD MOTION".

10. HOW THE SESSIONS ARE CONDUCTED - The sessions of the Sangguniang Bayan shall be open to the public unless otherwise ordered by affirmative vote of a majority of the members, there being a quorum.

11. OFFICIAL TIME & SCHEDULE OF SESSION) - The official time of the session is set at 9:00 AM and the session shall be held every 1st and third monday of each month.

12. ADJOURNMENT OF THE SESSION - A member may move and seconded by another for the adjournment of the session as agreed by the majority of the members.

On motion of Hon. Leodigario Gonzales, seconded by Hon. Ludovico Silang, be it;

NOW, THEREFORE, resolved as it is hereby resolved to adopt the Sangguniang Bayan Rules of Procedure of Bulalacao, Oriental Mindoro;

UNANIMOUSLY APPROVED.

There having no other business to be transacted so on motion of Hon. Ignacio Silang, duly seconded by Hon. Emelio Gregorio, the session was adjourned at 12:00 o'clock in the morning.
