RESOLUTION REQUESTING THE OIC PROVINCIAL GOVERNOR, THIS PROVINCE TO APPOINT FULL TIME OUTREACH WORKER (FTOW) TO BE ASSIGNED IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

WHEREAS, continuous increase of population in this municipality is alarming and needs special attention;

WHEREAS, due to population explosion, a great majority of the families here are experiencing financial difficulties and poverty, hence, it hinders the development of this town;

WHEREAS, there is a need of Full Time Outreach worker (FTOW) who will take charge of population control and information dissemination of the importance of Family Planning and Responsible Parenthood;

WHEREAS, Municipal Government of Bulalacao, owing to its meager income cannot shoulder the salary of ONE (1) Full Time Outreach Worker (FTOW) to be permanently assigned in this municipality;

WHEREAS, Full Time Outreach Worker (FTOW) is directly under the supervision and control of Provincial Population office and its salary will be taken from the Provincial Government;

NOW, THEREFORE, resolved, as it is hereby resolved, to request the OIC Provincial Governor, this Province, to appoint full time outreach worker (FTOW) to permanently assigned in this municipality, whose salary will be taken from the Provincial Fund;

RESOLVED, FURTHER, that copies of this resolution be furnished, the OIC Provincial Governor, the Provincial Population Officer, all of Calapan, Or. Mindoro, and the District Population officer, Roxas, Oriental Mindoro, for their information, consideration and appropriate action..
