REQUESTING THE MINISTRY OF EDUCATION, CULTURE AND SPORTS, MANILA THROUGH THE  
SCHOOLS DIVISION SUPERINTENDENT, CALAPAN, ORIENTAL MINDORO TO CREATE ITEMS  
FOR HEAD TEACHERS IN THE BARANGAY OF SAN ROQUE, MILAGROSA-SAN FRANCISCO, BALA-  
TASAN-MAASIN AND BENLI-AGONG COMBINE RESPECTIVELY

WHEREAS, the municipality of Bulalacao has fifteen (15) barangays, lo-  
cated separately in the remote areas;

WHEREAS, the Sangguniang Bayan has observed that head teachers are needed  
in some of these barangays because of far distance from the town proper and it  
is hard for them to go to town from time to time to consult or confer their pro-  
blems with the principal or the district Supervisor;

WHEREAS, the barangays that need head teachers are: a) barangay San Roque,  
b) Milagrosa-San Francisco, c) Balatasan-Massin, and Benli-Agong, combine res-  
pectively;

NOW, THEREFORE, resolved, as it is hereby resolved to request the Ministry  
of Education Culture and Sports, Manila through the Schools Division Superinten-  
dent, Calapan, Oriental Mindoro to create Items for Head teachers in the Baran-  
gay of San Roque, Milagrosa-San Francisco, Balatasan-Massin, and Benli-Agong,  
combine respectively;

RESOLVED, FURTHER, that copies of this resoluion be furnished, the Ministry  
of Education Culture & Sports, through the Schools Division Superintendent, Cala-  
pan, Oriental Mindoro for their consideration, the District Supervisor, District  
of Bulalacao, for his information, guidance and reference.


