RESOLUTION FIXING THE FLOOR PRICES (STARTING BID) ON THE PUBLIC AUCTION OF EACH MUNICIPAL WATER ZONE

"WHEREAS, exclusive fishery rights to take or catch " bangus " fry or kawag-kawag, lapu-lapu fry or fry of other species of fish propagation shall be awarded to the highest bidder in public auction to be conducted by Public Auction Committee;

"WHEREAS, Article 235 par (b) sub par (1) of the Implementing Rules and Regulations of Republic Act 7160 empowers the Sangguhiang Bayan to determine how public bidding may be conducted;

NOW THEREFORE:

BE IT RESOLVED as it is HEREBY RESOLVED that the fixed floor prices (starting bid) on the public auction of each municipal water zone shall be as follows:

a) Zone I	-	₱ 20,000.00
b) Zone II	-	35,000.00
c) Zone II-A	-	Government Reservation
d) Zone III	-	45,000.00
e) Zone IV	-	40,000.00
f) Zone V	-	45,000.00
g) Zone VI	-	30,000.00

RESOLVED FURTHERMORE, that copies of this Resolution be posted for information and guidance of interested persons;


