RESOLUTION NO. 44

RESOLUTION REVERTING P60,000.00 TO BE TAKEN FROM 20% DEVELOPMENT FUND, FOR THE REPAIR OF MUNICIPAL SERVICE JEEP, PURCHASE OF DIESEL ENGINE, TIRES AND OTHER SPARE PARTS.

WHEREAS, Municipal service jeep is indispensable in this Municipality, due to many reasons to wit: inspection and monitoring of Municipal development projects; tax information dissemination and collection campaign; bringing of patients to Roxas District Hospital in case of emergency and utilize as fastest and convenient means of transportation of Municipal officials in attending conferences, meetings, seminars held at Calapan and other places outside of this Municipality;

WHEREAS, existing municipal service jeep needs renovation in order to serve its purpose;

WHEREAS, the following funds from the 20% Development fund incorporated in the 1991 Annual Municipal Budget, will be reverted, for the repair of municipal service jeep, purchase of diesel engine, tires and other spare parts;

- a) Cementing of C. Bendolo St. . . . P28,000.00
- b) Cementing of A. Salas St. . . . 32,000.00

T o t a l . . . P 60,000.00

NOW, THEREFORE, resolved as it is hereby resolved, to revert the amount of P60,000.00 from the 20% Development Fund, for the repair of Municipal service jeep, purchase of diesel engine, tires and other spare parts.
