" RESOLUTION NO. 005

RESOLUTION INCREASING THE SALARY RATE OF THE CASUAL EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO

WHEREAS, casual employees of the Municipal Government of Bulalacao are presently receiving a daily rate of Fifty Pesos (P50.00) only;

WHEREAS, the local leadership of the Municipal Government feels that the salary rate of the casual employees presently receiving cannot cope up with the spiraling cost of living;

WHEREAS, under par.(viii), sub-section 1 Section 447, Article III of Republic Act 7160, the Sangguniang Bayan shall "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds . . . ";

NOW THEREFORE:

RESOLVED as it is HEREBY RESOLVED to increase as it HEREBY INCREASING the salary

rate of the casual employees from Fifty Pesos (P50.00) per day to Sixty Three Pesos and Twenty Five Centavos (P63.25) per day;

RESOLVED FURTHER, that this Resolution shall take effect upon the approval of the Mayor;

RESOLVED FURTHERMORE, to submit copies of this Resolution to the Municipal Treasurer, Bulalacao, Oriental Mindoro for his information and guidance.






