ORDINANCE NO. 93-07-047

AMENDING SECTION 5K.01 PAR (b) AND PAR (h), ARTICLE K OF THE REVISED REVENUE CODE OF BULALACAO, ORIENTAL MINDORO, 1991

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

SECTION 1. Section 5K.01 par (b) and par (h), Article K of the Revised Revenue Code of Bulalacao, Oriental Mindoro, 1991 is hereby amended to read as follows:

" Section 5K.01. Imposition of Fee. The following fees shall be collected for the water supply service rendered by the Municipality of Bulalacao, Oriental Mindoro in the operation of the Bulalacao Waterworks System."

(b) For unmetered services:

1. Flat rate consisting of two (2) faucets only.

Residential	-	₱ 30.00
Commercial	-	50.00
Industrial	-	100.00

(h) Tapping fees:

For ½ diameter	-	₱ 10.00
