EARNESTLY REQUESTING HONORABLE JESUS M. PUNZALAN, CONGRESSMAN, 2ND DISTRICT ORIENTAL MINDORO TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF BARANGAY HALL, BARANGAY MAUJAO, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Barangay Hall serves as a venue for both the barangay officials and the constituents alike to deliberate, articulate and crystallize matters surrounding them and formulate the best solutions beneficial and for improvement of all;

"WHEREAS, the provision of Barangay Hall in Barangay Maujao, Bulalacao, Oriental Mindoro would signify a decent and dignified place for barangay officials to meet and discuss issues pertinent to the welfare of their constituents;

"WHEREAS, Bulalacao, Oriental Mindoro is a Fifth Class Municipality and classified as a Pro-Poor Municipality under Presidential Proclamation No. 390, hence hounded by financial constraints that construction of Barangay Hall for each of its fifteen (15) component barangays is virtually impossible;
