AN ORDINANCE REGULATING THE ANCHORAGE, DOCKING AND BERTHING OF ALL MOTORIZED BANCAS AND OTHER VESSELS OF SIMILAR NATURE AND KIND ON BOTH SIDES OF THE RIVERBANKS OF THE CABURAYAN RIVER, POBLACION, BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro; that:

SECTION 1. Provisions of existing ordinances to the contrary notwithstanding, to minimize obstructions and impediments and to avoid occurrence of accidents, no person shall be allowed to anchor, dock and overstay for unreasonable long period of time on both sides of the riverbanks of Caburayan River, Poblacion, Bulalacao, Oriental Mindoro;

SECTION 2. The " bancas " used by person on contract basis with the Municipal Government of Bulalacao, Oriental Mindoro for " tawiran " purposes are hereby included from said regulatory;

SECTION 3. Operators and shippers of motorized bancas and vessels are not allowed to standby or overstay for drydocking and repairing purposes except to load and unload cargoes on the said specified places and to leave right away after accomplishing said loading and unloading of cargoes;

SECTION 4. Any violation of the provisions of this Ordinance shall be punished by a fine not less than Two Thousand Pesos (P2,000.00) but not exceed Two Thousand Five Hundred Pesos (P2,500.00) or by an imprisonment of one (1) month but not more than (3) months, or both such fine and imprisonment at the discretion of the Court;

SECTION 5. All Ordinances inconsistent hereof are hereby repealed or modified accordingly;

SECTION 6. This Ordinance shall take effect ten (10) days after its posting;
