"RESOLUTION NO. 95-08-053

EARNESTLY REQUESTING THE PROVINCIAL AUDITOR, COMMISSION
ON AUDIT, TO CONDUCT AN INVESTIGATION, EXAMINATION AND
AUDIT OF THE RECEIPTS, EXPENDITURES AND USES OF FUNDS AND
PROPERTY ALLOCATED FOR THE CONSTRUCTION AND OPERATION OF
BULALACAO MUNICIPAL HOSPITAL

"WHEREAS, on March 9, 1990, Congress passed Republic
Act No. 6910 which in full is as follows:

' AN ACT ESTABLISHING A TEN-BED MUNICIPAL
HOSPITAL IN THE MUNICIPALITY OF BULALACAO
PROVINCE OF ORIENTAL MINDORO TO BE KNOWN
AS THE BULALACAO MUNICIPAL HOSPITAL, AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of
Representatives of the Philippines in
Congress assembled:

SECTION 1. There shall be established,
under the supervision of the Director of
Medical Services of the Department of
Health, a ten-bed municipal hospital in
the Municipality of Bulalacao, Province
of Oriental Mindoro, to be known as the
Bulalacao Municipal Hospital.

SECTION 2. The amount necessary to carry
out the provisions of this Act shall be
charged against the appropriations autho-
rized for the purpose under the Fiscal Year
1989 General Appropriations Act. There-
after, such sums as may be necessary for
the operation and maintenance of the herein

hospital shall be included in the Annual General Appropriations Act.

SECTION 3. Before the construction of the hospital, the Secretary of Health shall issue a written assurance that personnel of the hospital will be appointed and that funds for its maintenance and operation have been appropriated.

SECTION 4. This Act shall take effect upon its approval.

Approved, March 9, 1990.;

"WHEREAS, by 1992, devoid of any explanation, the construction of Bulalacao Municipal Hospital was unexpectedly and abruptly halted without completing the Works within the specified contract time;

"WHEREAS, this senseless delay in the completion and operation of the subject hospital is viewed by the people of this Municipality as a blatant betrayal of public trust as it has become an overwhelming sentiment by the hapless and helpless residents that whosoever caused this delay is/are unmindful of their plight and suffering;

"WHEREAS, particularly odious and revolting to the resident's sense of propriety and morality in government service were the lost opportunities to save lives had the hospital been operational;


"WHEREAS, this being the case, this anomalous delay in the construction of Bulalacao Municipal Hospital needs an urgent investigation to know the reasons for this delay, determine the manner by which the funds and properties were used; Now therefore, be it;


RESOLVED, AS IT IS HEREBY RESOLVED, To earnestly request the Provincial Auditor, Commission on Audit, Calapan, Oriental Mindoro, to conduct an investigation, examination and audits of the receipts, expenditures and uses of funds and property allocated for the construction and operation of Bulalacao Municipal Hospital established under Republic Act Numbered 6910;


