AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM
OF AGREEMENT WITH THE BENEFICIARIES OF CORE SHELTERS PRO-
JECTS AT BARANGAYS CAMPAASAN AND CAMBUNANG, RE: PURCHASE
OF LOTS AND MODE OF PAYMENT THEREOF

"WHEREAS, the Municipal Government of Bulalacao, Oriental
Mindoro cognizant of the welfare of its people
continues to seek various developmental projects
beneficial and conducive to their immediate needs;

"WHEREAS, many residents of this municipality remain to be
homeless, that acquiring such simple protective
shelter which they could proudly call their own
would be a satisfying fulfillment for them;

"WHEREAS, the Municipal Government of Bulalacao, Oriental
Mindoro, decided to purchase lots and implement
guidelines and mode of payment thereof affordable
by the least privileged. There are two alternatives
to choose from: (a) payment of Twenty-Five Pesos
(P25.00) monthly payable for Twenty-Five years
(25) and (b) Fifty Pesos (P50.00) monthly payable
for Twelve years and six months (12½);


RESOLVED AS IT IS HEREBY RESOLVED: To authorize Hon. Gemma
G. Salas, Municipal Mayor, to enter into a Memo-
randum of Agreement with the beneficiaries of Core
Shelters Projects at Barangays Campaasan and Cam-
bunang, stipulating therein the mode of payment,
either for 25 or 12½ years without prejudice to the
lumpsum payment for those who can afford;


RESOLVED FURTHER, to let copies of this Resolution be fur-

for her guidance, reference and proper action;


