EARNESTLY REQUESTING CHIEF SUPERINTENDENT REYNALDO ACOP, REGIONAL DIRECTOR, REGIONAL POLICE COMMAND 4, CANLUBANG, LAGUNA TO PRIORITIZE THE PNP PERSONNEL AT THE PNP BULALACAO STATION, BULALACAO, ORIENTAL MINDORO IN THE ISSUANCE OF SHORT SERVICE FIREARMS

"WHEREAS, law enforcement agencies such that of the PNP personnels are among the major components in the operation of the criminal justice system responsible for the full implementation of laws, decrees and ordinances, prevention of crimes and other criminal acts, protection of life and property, maintenance and preservation of peace and order and safeguarding the rights of every citizens against the oppressors;

"WHEREAS, it is always believed that the presence of a uniformed police officer in a designated area would bring security to the law-abiding citizen however, fear to those criminals and rebels;

"WHEREAS, the Bulalacao PNP Station, Bulalacao, Oriental Mindoro has a total strength at present of nineteen police officers but sad to say, only two of them has short service firearms which are necessary in carrying out their task more effectively and efficiently;

"WHEREAS, it has made known to this August Body that the Regional Police Command 4 is presently issuing short service firearms wherein the Bulalacao PNP Station will be grateful if this request would be given top priority; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Chief Superintendent Reynaldo Acop, Regional Director, Regional Police Command 4, Canlubang, Laguna to prioritize the PNP personnel at the PNP Bulalacao Station, Bulalacao, Oriental Mindoro in the issuance of short service firearms;
