EARNESTLY REQUESTING THE HONORABLE ANDREW GONZALES, SECRETARY, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF THREE (3) UNITS 3-CLASSROOM BUILDING FOR TAFARMA, CABUGAO AND SAN FRANCISCO ELEMENTARY SCHOOLS ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 17, Article II of the Constitution provides that the State shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress and promote total human liberation and development;

"WHEREAS, the newly opened Tafarma Elementary School still lacks a school building to house the pupils and school buildings of Cabugao and San Francisco Elementary Schools are heavily ruined and dilapidated which pose danger to the lives and properties of both the teachers and pupils particularly during the onslaught of bad weather condition;

"WHEREAS, the provision of additional school buildings at the abovementioned barangays is necessary in order to house and accommodate the increasing enrollees every year;


"WHEREAS, it is believed that quality education ensures all possible conditions for the fullest development of the pupils given the right opportunities and enough facilities to achieve educational goals; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Andrew Gonzales, Secretary, Department of Education, Culture and Sports to allocate funds for the construction


