EARNESTLY REQUESTING THE HONORABLE BLAS F. OPLE, SENATE PRO TEMPORE, SENATE OF THE REPUBLIC OF THE PHILIPPINES TO APPROPRIATE FUNDS FROM HIS COUNTRYWIDE DEVELOPMENT FUND FOR THE CONSTRUCTION OF THREE (3) CLASSROOM BUILDING AT BARANGAY SAN ROQUE, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO
