EARNESTLY REQUESTING THE HONORABLE GARY B. TEVES, CHAIRMAN, COMMITTEE ON RURAL DEVELOPMENT, HOUSE OF REPRESENTATIVE, MANILA TO APPROPRIATE FUNDS FOR THE CONSTRUCTION OF THE IRRIGATION SYSTEM AT SITIO CABILLAN, BARANGAY NASUCOB AND BARANGAY MAUJAO BOTH OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is one among the 15 municipalities of Oriental Mindoro with a total land area of 305,100 hectares whose major source of income of the residents is agriculture;

"WHEREAS, it is noted that Bulalacao produces a high quality of garlic aside from rice, corn and vegetables, however, the municipality suffers a big deficit in terms of total production lately, due to its geographical condition;

WHEREAS, one of the major factors that aggravates the problem added to the inadequacy of technical knowledge on the part of the farmers and high cost of production, is the absence of infrastructural support facilities such that of an irrigation system;

"WHEREAS, in the face of worsening crisis in terms of agricultural products, there is a dire need to provide an irrigation system which could provide water essential for the production of these most valuable crops regardless of climate; Now, therefore be it


RESOLVED AS IT IS HEREBY RESOLVED"; To: Earnestly
